

## **empty tomb®, inc. Mission Match® Donation Terms and Conditions**

Thank you for donating to the empty tomb, inc., Mission Match effort. The following Donation Terms and Conditions provide a shared understanding regarding donations.

Gifts will be applied to Mission Match activities as defined by the Mission Match Application Guidelines.

**Online Donations.** empty tomb, inc. and Mission Match online donations are made through the PayPal® service.

**Privacy Policy.** empty tomb, inc. does not retain donation credit card information. empty tomb's policy is to use contact information to communicate with the donor solely about the works of empty tomb. For example, an email address associated with a Mission Match donation will be used to communicate about Mission Match activities. empty tomb, inc. will not share, sell, or in any way make its mailing lists available to any other organization or company for their use.

**Refund Policy.** In the event that an individual becomes aware of an error in a donation (e.g., an unintended duplicate donation), contact [info@emptytomb.org](mailto:info@emptytomb.org) within 14 days of the donation date. As appropriate, any refund that may be available to the donor will be issued electronically to the same card that was used to make the original transaction. If an individual becomes aware of fraudulent use of his or her credit card, the individual should contact the individual's credit card provider.

**Allocation of Mission Match Donations.** Donations to the Mission Match effort are allocated as follows. Of the total, 85% is available as Matching Contributions to congregations. That leaves 15% to be allocated for empty tomb's work, including interaction with the congregations that receive the Matching Contributions and/or may receive information about Matching Contributions, including through information posted on the World Wide Web and in other materials, and for general expenses, including, but not limited to, fundraising as well as research and education activities regarding church giving and membership patterns that contribute to an information framework for the Mission Match effort.
